


HALIFAX RENTAL OFFICE MARKET OVERVIEW


KW Commercial surveyed over 13 million square feet of leased office space in 167 buildings throughout HRM. The Halifax office market recorded good leasing activity in Q4 2021 with 50,432 sq. ft. of positive net absorption. The vacancy rate is down 50 basis points (bps) to 14.6% quarter over quarter. The average net asking rental rates remained at \$14.54 per sq. ft. and the average taxes and operating costs are at \$12.31 psf. There are currently 2 new Class A suburban office projects under construction that will add to the inventory in 2022. Armco Capital's 168 Hobson Lake Drive in Bayers Lake, Halifax will be completed in Q1 2022 and will add 95,000 sq. ft. of Class A office space. Armour Group's Westway IV in West Bedford is also under construction and will be adding 105,000 sq. ft. of Class A suburban office space. This project is set to be completed in Q3 2022.
